




FUND OBJECTIVE

The Future Titans Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to South African companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to own fast growing, mispriced, mid- and small-cap shares, "Future Titans", so as to achieve real long-term capital growth ahead of its benchmark.

MONTHLY COMMENTARY

Future Titans was up 2.64% in December versus the flexible index return of 0.92%.

2016 was a particularly difficult year driven by South African and global political events. In addition the zero, and sometimes negative, interest rate environment in developed countries distorted global markets. Bond investors piled into global defensive equities such as consumer staple stocks, pushing valuations to very high levels. By comparison the small and mid-caps became cheaper as the momentum trade pushed investors into the hot performing sectors. The Trump trade has however changed all as the political emphasis swung from one of monetary to fiscal stimulus, driving rates higher and somewhat normalizing markets.

2017 still holds several political risks with Brexit, French and Italian elections, and Trump political and economic policies needing to be implemented. The value stocks, and in particular the small and mid-caps stocks, look cheap and are expected to deliver better results on the back of an improving economic backdrop.

Sirius Real Estate, the fund's largest holding, announced a transaction whereby they would sell a business park for €85m at a yield of 5.7%. The proceeds from the transaction will be recycled into buying new assets at 8+ yields which will grow over time to +/-15% yields. This is a very positive transaction and we have seen the share price react accordingly.



Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Performance has been calculated using net NAV to NAV numbers with income reinvested. The performance for each period shown reflects the return for investors who have been fully invested for that period.
