


**FUND OBJECTIVE & STRATEGY**

The Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction

**WHO SHOULD INVEST**

The fund is a high risk, high return fund and should be invested in as a complementary investment to any long-term blue-chip portfolio.

**MONTHLY COMMENTARY**

Future Titans was up 3.26% for July against the Flexible Index of 3.24%.

Future Titans largest holding, Hulamin, delivered a very pleasing interim result with earnings up 17% with a 14% stronger Rand headwind against the Dollar. This improvement was driven by strong cost control, aluminium up 22% over the period, 8% higher volumes and an improvement in Dollar rolling margins. Importantly Hulamin is aiming to be debt free in the next 24 months and will be moving the working capital requirements from Rand to Dollar funding which more than halves the interest costs. Management have started planning an entry into upstream aluminium production where they have several options and more importantly downstream expansion which has higher margins. In this regard Hulamin have landed a large order for aluminium frames to be mounted on Boeing aircraft for WiFi satellite receivers. Management are targeting R1.70 in earnings to December 2019 which implies a 3.7x PE forward making it one of the cheapest industrial stocks on the JSE.

Interwaste released a trading statement indicating earnings will be up between 35% and 42%. If this trend continues into the second half Interwaste trades on a forward PE of 5.5x. Unfortunately the smell and noise around the Midrand FG facility does create some market confusion, but the facility is rapidly filling up and is scheduled for closure in a few years and is one of seven Interwaste facilities. Metair also released a trading statement indicating earnings will be up between 105.6% and 114.8%. If this


