




FUND OBJECTIVE & STRATEGY

The ClucasGray Equilibrium Prescient Fund is a Regulation 28 compliant, multi-asset high equity fund. The Fund aims to provide long term capital growth ahead of its peer group by delivering both income and capital growth in excess of inflation over time. The Fund aims to achieve these objectives through an active approach to asset allocation, and via superior stock selection. Fundamental analysis, a valuation discipline and a belief that inefficient markets create opportunities in mispriced assets underpin both our asset allocation and stock selection process.

MONTHLY COMMENTARY

February was a particularly tough month for global equity markets. Fears around the stagnation of global economic activity as a result of the global reaction to the Corona virus have sent shockwaves through equity markets. The last week of February was the worst week since the global financial crisis, with the JSE and most other global indices declining by over 10%.

The ClucasGray Equilibrium Prescient Fund was not immune from the carnage, with the exposure to equities hurting performance over the last two months. During the market correction, we have taken advantage of the sell-off to add to exposures in select attractively priced companies. In addition, South African bonds have been relatively resilient in the face of the recent Emerging Market driven currency weakness - we believe they continue to look attractive, more so given collapse in global bond yields over the last month. Despite performing relatively well against peers and matching inflation over most periods since inception, we are naturally disappointed with the low nominal returns. Whilst it has been a painful journey getting to this point, the only silver lining in the otherwise ominously dark clouds, is that many valuations are now as compelling as they have potentially ever been.



A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Funds are priced at either 3pm or 5pm depending on the nature of the Fund. Prices are published daily and are available on the Prescient website.
