The ClucasGray Equilibrium Prescient Fund is a Regulation 28 compliant, multi-asset high equity fund. The Fund aims to provide long term capital growth ahead of its peer group by delivering both income and capital growth in excess of inflation over time. The Fund aims to achieve these objectives through an active approach to asset allocation, and via superior stock selection. Fundamental analysis, a valuation discipline and a belief that inefficient markets create opportunities in mispriced assets underpin both our asset allocation and stock selection process.


The fund is an ideal wealth creation vehicle for investors with a medium to long-term investment horizon.

MONTHLY COMMENTARY

Investment markets around the world have continued to rally off the lows of March 2020. April was a better month for investors with all major JSE indices gaining over 10% in the month, and the All Bond Index gaining 4%. Following an extremely disappointing start to the year, the ClucasGray Equilibrium Fund gained over 8% in the month.

South African interest rates were reduced by a further 1% in April – rates are now 2.25% lower since the beginning of the year. The Reserve Bank estimates this could free up R75bn in disposable income, nearly 1.5% of GDP. Rate cuts, coupled with a material reduction in the price of fuel, would ordinarily be deemed stimulatory for the consumer economy, yet somehow “this time feels different”. Lower cash rates and a steeper yield curve has meant investors are required to take more duration risk to deliver the attractive yields we have grown accustomed to in the fixed income market. Within equities, our focus has been on analyzing the ability of companies to generate a more normal level of earnings and cash flows into 2021 and beyond, and valuing them accordingly. We continue to believe investors have been presented with a wide range of attractive opportunities, both within the equity and fixed income markets, and have positioned the ClucasGray Equilibrium Fund to take advantage of many of these.



During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Funds are priced at either 3pm or 5pm depending on the nature of the Fund. Prices are published daily and are available on the Prescient website.
