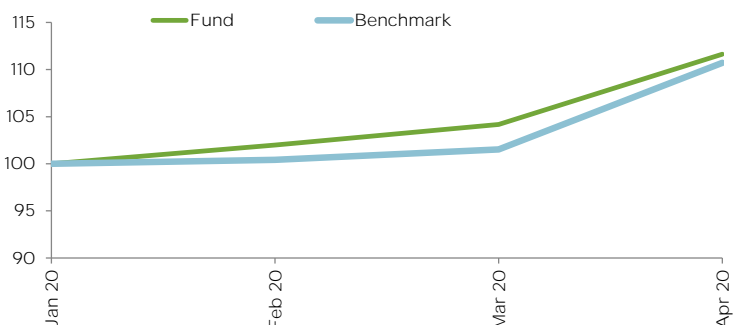
The fund is an ideal wealth creation vehicle for investors with a medium to long-term investment horizon.

MONTHLY COMMENTARY

Global markets rebounded during April, as both developed- and emerging markets added 11.0% and 9.2% respectively, following unprecedented monetary stimulus announced by central banks across the world. The biggest concern for businesses at this time is cash flow, or the lack thereof. The first signs of the devastating impact this pandemic will have on the global economy became evident in April as the U.S (-4.8%) and Eurozone (-3.8%) recorded contractions in first quarter GDP numbers. In the U.S, jobless claims increased by over 30 million over the last six weeks following a jump in unemployment, as the worlds largest economy has slowed down significantly amid the global lockdown.

In the fund, we continue to invest in companies we believe to be of the highest quality, with minimal liquidity concerns in the near term and which are trading below our estimated intrinsic value. As such we have decided to sell our holding in Johnson Control International and started to build a position in Amdocs. Amdocs is a leading provider of information systems, billing services, CRM services and data center services to some of the world largest telecommunication companies. They have a predictable growth profile, stable margins and a capital light business model with net cash on the balance sheet.

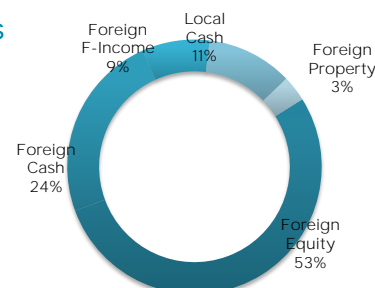

The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Funds are priced at either 30m or 50m depending on the nature of the Fund. Prices are published daily and are available on the Prescient website.
