The ClucasGray Equilibrium Prescient Fund is a Regulation 28 compliant, multi-asset high equity fund. The Fund aims to provide long term capital growth ahead of its peer group by delivering both income and capital growth in excess of inflation over time. The Fund aims to achieve these objectives through an active approach to asset allocation, and via superior stock selection. Fundamental analysis, a valuation discipline and a belief that inefficient markets create opportunities in mispriced assets underpin both our asset allocation and stock selection process.

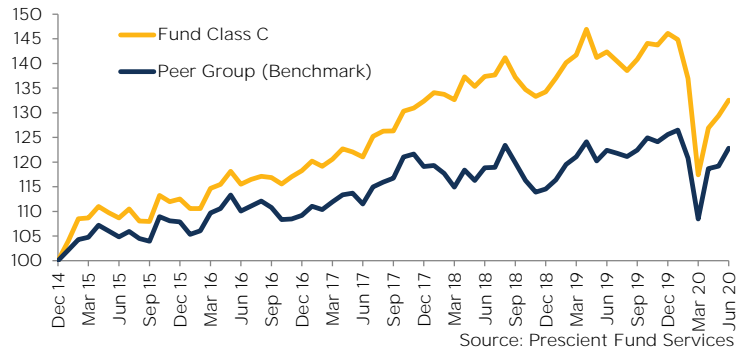
The fund is an ideal wealth creation vehicle for investors with a medium to long-term investment horizon.

MONTHLY COMMENTARY

Following the Covid crisis which impacted markets significantly in the first quarter, the second quarter of 2020 saw a very strong rally in most markets. The ClucasGray Equilibrium Prescient Fund gained nearly 13% in the quarter, through a combination of equity selection and asset allocation. A number of key holdings enjoyed significant gains, with African Rainbow, Exxaro, Anglos, Anglo Plats and Naspers all gaining over 30% in the quarter. The decision to increase global equity exposure in March helped, with most major indices delivering a Dollar return of around 20% in the quarter, and the repatriation of some global cash has also been beneficial, given that the Rand has strengthened off its crisis lows. The portfolio is well exposed to Bonds, and the All Bond Index gained 10% in the quarter.

We have spoken in prior commentaries how the fund was not positioned for the Covid crisis, and its impact is evident in the shorter term performance numbers. Whilst we are unfortunately unable to rewind the clock, we feel we have acted decisively to position the portfolio to benefit from the numerous opportunities that the crisis has presented. 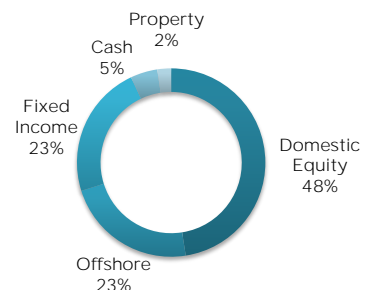

The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Funds are priced at either 3pm or 5pm depending on the nature of the Fund. Prices are published daily and are available on the Prescient website.
