Fundamental analysis, a valuation discipline and a belief that inefficient markets create opportunities in mispriced assets underpin both our asset allocation and stock selection process.

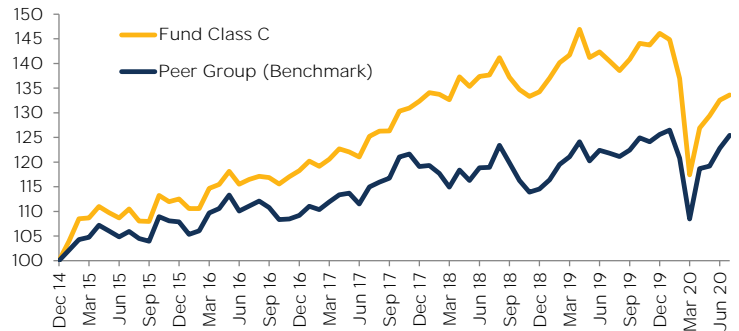
The fund is an ideal wealth creation vehicle for investors with a medium to long-term investment horizon.

MONTHLY COMMENTARY

August saw a continuation of some of the themes that have been playing out for the last few months. There is increasing evidence of a recovery in activity levels in many global economies, most notably China, following the gradual reopening of their economies. Equity markets continued to rise off their March lows, and improving demand has seen underlying commodity prices rise. The JSE was boosted by the performance of most Resource companies - large weightings in the diversified miners helped the performance of the fund. Most of them were up around 5%, with African Rainbow Minerals gaining 14% in the month. Bonds also enjoyed a positive month, with the All Bond Index gaining nearly 1%. The fund's offshore exposure also contributed positively for the month as the World Index moved up 5% in USD terms during July. The backdrop of an improving global economy, record levels of stimulus and rising commodity prices would typically be a constructive one for emerging markets, and South Africa. Coupled with one of the most aggressive reductions in South African interest rates on record, it is not inconceivable that the next few years would see a recovery in domestic demand - given current valuations the net effect could prove rewarding for investors. 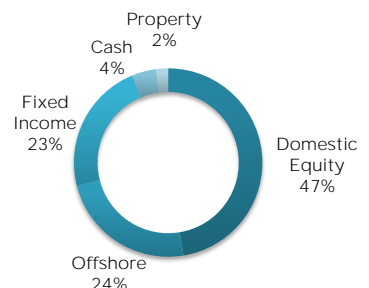

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
